### **Covid-19 Trip Health and Safety Policy**

- 1. We will make every effort toward Covid-19 safety through careful consideration of our accommodations and activities, as well as healthy practices with frequent hand-washing and wearing masks in public areas when social distancing is not possible.
- 2. Effective June 12, 2022, The Centers for Disease Control and Prevention (CDC) rescinded the order requiring persons to show a negative COVID-19 test result or documentation of recovery from COVID-19 before boarding a flight to the United States. Vaccination requirements are still in effect. Because of the fluid nature of travel regulations, we will continue to reevaluate our guidelines and testing requirements for re-entry into the U.S.
- 3. Consistent with health regulations as updated June 12, 2022, by the <u>U.S. Embassy in Peru</u>, all travelers must be fully vaccinated 14 days prior to boarding an incoming flight to Peru OR must present a molecular test with a negative result (within 48 hours) prior to boarding.
- 4. Any participant or guide who tests positive for COVID-19 within 14 days of the scheduled departure, will not be allowed on the trip. The trip fee is non-refundable at this date, so travel insurance is essential.
- 5. If guides or participants experience any COVID-19 or flu-like symptoms during the trip, they may be physically distanced from the rest of the group and a determination will be made to seek definitive care.
- 6. Any associated costs are the individual's responsibility, including costs of guarantine.
